Mayor Leutwyler said there were two quick orders of business to take care of this evening. He explained at the reorganization meeting there was not a roll call for the nominations of Mayor and Deputy Mayor.

Mayor Leutwyler said there was one more item of business that is not on the prepared agenda. He said there needed to be a resolution to give the Court Administrator, Christine Ward authority to appoint a temporary clerk for call-outs.

ON MOTION OF DEPUTY MAYOR SORCHIK, SECONDED BY COMMITTEEMAN MARINARI RESOLUTION NO. 2012-99, A RESOLUTION OF THE TOWNSHIP OF PLUMSTED, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING CHRISTINE WARD, COURT ADMINISTRATOR TO APPOINT TEMPORARY COURT PERSONNEL TO DO CALL-OUTS IN HER ABSENCE, WAS ADOPTED. ROLL CALL VOTE: ALL AYES.

This resolution would be for the week of January 23rd while Ward is on vacation. Business Administrator Dancer recommended that the rate of pay shall be consistent with the current as specified in the current salary ordinance.

ON MOTION OF COMMITTEEMAN TROTTA, SECONDED BY COMMITTEEMAN WYSONG RESOLUTION NO. 2012-98, A RESOLUTION OF THE TOWNSHIP OF PLUMSTED, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE CONVENING OF AN EXECUTIVE SESSION IN ACCORDANCE WITH THE OPEN PUBLIC MEETINGS ACT, WAS ADOPTED. ROLL CALL VOTE: ALL AYES.
