

**RESOLUTION NO. 2014-122**

**RESOLUTION OF THE TOWNSHIP OF PLUMSTED  
COUNTY OF OCEAN, STATE OF NEW JERSEY,  
ACCEPTING THE QUOTE OF RST LAWN CARE, LLC TO PROVIDE  
GROUNDS SERVICES TO PUBLIC LANDS WITHIN  
THE TOWNSHIP OF PLUMSTED**

**WHEREAS**, the Township Committee of the Township of Plumsted authorized June d. Madden, CFO/QPA to solicit quotes for Public Grounds Maintenance; and

**WHEREAS**, at the time, place and date set for the for receipt of quotes one (1) quote was received by the Township of Plumsted; and

**WHEREAS**, said quote has been reviewed by the Chief Financial Officer/Purchasing Agent who has determined that RST Lawn Care, LLC submitted a responsible quote in accordance with the specifications, with a quote of \$35,950.00 (\$23,000.00 for athletic fields and \$12,950.00 for municipal grounds maintenance) as set forth in the attached Schedule "A"; and

**WHEREAS**, it is the desire of the Mayor and Township Committee of the Township of Plumsted to accept the quote for 2014 for Public Grounds Maintenance as submitted by Ronald Tabor's Lawn Service, Inc. in compliance with all applicable local, State and Federal statutes, laws and regulations; and

**WHEREAS**, the term of the agreement shall be for two (2) March to November seasons, and shall commence on March 15, 2014, and expire on November 12, 2015. The Township may terminate the agreement at any time upon thirty (30) days prior notice to the Contractor. Pursuant to N.J.S.A. 40A:11-15, the Township may renew the agreement for two (2) additional one season terms upon sixty (60) days written notice to the contractor prior to the expiration of the then-current term. All terms and conditions of the agreement, including price, shall remain the same.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Township Committee of the Township of Plumsted, County of Ocean, State of New Jersey, as follows:

1. That the Mayor and Township Committee of the Township of Plumsted do hereby accept the quote for 2014 for Public Grounds Maintenance (03/15/14 to 11/12/15) submitted by RST Lawn Care, LLC in compliance with all applicable local, State and Federal statutes, laws and regulations.
2. That the Mayor and Township Clerk are authorized to execute a contractual agreement for 2014 for Public Grounds Maintenance (03/15/14 -11/12/15) with, RST Lawn Care, LLC contingent upon a Certification of Availability of Funds by the Plumsted Township Chief Financial Officer in an amount not to exceed \$35,950.00.
3. That the term of the agreement shall be for two (2) March to November seasons, and shall commence on March 15, 2014, and expire on November 12, 2015. The Township may terminate the agreement at any time upon thirty (30) days prior notice to the Contractor. Pursuant to N.J.S.A. 40A:11-15, the Township may renew the agreement for two (2) additional one season terms upon sixty (60) days written notice to the contractor prior to the expiration of the then-current term. All terms and conditions of the agreement, including price, shall remain the same.
4. That a certified copy of this resolution be forwarded to RST Lawn Care, LLC and June d. Madden, CFO.
